**PTIN DEADLINE 12/31/12** 

We have been advised that the IRS Website may be down for maintenance beginning 12/29/12. Because of this, be sure to renew or obtain your PTIN prior to this date! Email your District Manager with your new PTIN, or confirm with your DM that you have renewed it.



### CHECKING YOUR WORK SCHEDULE ON JHNET



Schedules are posted now for Walmart and will soon be posted for Storefront and Sears locations (by 1/1/13). If you are a new employee, we will do our best to pair you with a returning preparer. Expect to continue training and development in *your* first few days on the job! New schedules are posted each week by Wednesday.

Login to JHNET and click on the eServices Tab. Choose "Employee Scheduling" and you can see your Weekly View by clicking on "Employee Week View".

You must notify your Office Manager immediately if there is a conflict. We schedule based on the availability that you provided us so if that changes, you must let us know.

# WHAT IS THE FINE PRINT ON PROMOTIONAL OFFERS?

#### WE WILL MATCH WHAT YOU PAID LAST YEAR!

- 1. We will match a fee from last year of \$99 or less with the \$99 promotion.
- 2. Customer must show proof of what they paid last year.
- 3. If it is a prior year customer, we will charge them at least \$99; unless the calculated fees in ProFiler come up less.

#### SWITCH TO US AND SAVE \$50 OR PAY \$50 LESS THAN YOU DID LAST YEAR OR DARE TO COMPARE

- 1. Customer must show proof of tax prep fee from last year.
- 2. A copy of their proof must be copied/scanned into their file.
- 3. Valid on fees paid for tax preparation only over \$150.

#### PRACTICE MAKES PERFECT!!

We need all of you to become experts in Jackson Hewitt's Proprietary Tax Software Program – ProFiler – by the time you are engaging customers and preparing tax returns. To accomplish this, we give you remote access to the software through a program called "LOGMEIN". During a LOGMEIN Session, you will be logging in with security information that we will provide when you become hired. Your computer, in turn, takes on the characteristics of the computer you are "talking to" during this process. If you have not received these instructions and are ready to start practicing, please email or call your District Manager (contacts on Page 2). # SPOTLIGHT ON INVITING & ENGAGING CUSTOMERS IN THE EARLY SEASON

Invite & Engage is something we must all do to drive early tax return preparation in our offices. At press time, decisions were still not made relative to the "fiscal cliff", creating uncertainty and confusion among taxpayers. It will be your chance to engage customers and offer to start their tax return early. You can do this by requesting that they bring in their last check stub. You can then check to see if we are able to download their W-2 or them. Even if we do not have the ability to download the W-2, we can start their tax return with their last pay stub(s) and get a reasonable calculation of the refund based upon the information they provide. When they receive their W-2 forms, they can return for verification of information and filing of their return. This will greatly decrease their wait time during the busy part of the season when everyone's filing. Their return visit will be quick & easy!
